## NOTIFICATION ON THE CHANGE OF NUMBER OF VOTES IN GETBACK S.A.

Dear Sirs.

In accordance with article 69.1.1 of the Act of July 29, 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organized Trading, and Public Companies ("the Act"), I hereby notify, on behalf of JP MORGAN ASSET MANAGEMENT (UK) LIMITED, about a change of number of votes during General Shareholders Meeting of GetBack S.A. with its registered seat in Wrocław ("the Company"), as a result of the execution on 17 July 2017 of block trade transaction resulting from settlement of prefunding for JP MORGAN ASSET MANAGEMENT (UK) LIMITED.

1. Date and nature of event resulting in change of number of shares that is subject to the notification:

On July 17, 2017 JP MORGAN ASSET MANAGEMENT (UK) LIMITED acquired 4,300,000 Company's shares in block trade transaction. This acquisition resulted from the settlement of prefunding granted to JP MORGAN ASSET MANAGEMENT (UK) LIMITED, which submitted declaration during book-building process that was conducted by Haitong Bank, S.A. Spółka Akcyjna Branch in Poland and other mangers of the offering within initial public offering of Company's shares.

Before execution of the transaction indicated in point 1, JP MORGAN ASSET MANAGEMENT (UK) LIMITED did not hold any shares in the Company.
